

CEMETERY RULES:

ALL RULES AND REGULATIONS OF THE DIOCESE OF SYRACUSE
APPLY TO ST. JOSEPH'S & ST. PATRICK'S CEMETERIES
July 1, 2022

Lot owners cannot transfer or sell lots without permission from St. Joseph's or St. Patrick's cemeteries and must be sold for the original sale price.

If a grave is returned to St. Joseph's or St. Patrick's Cemeteries the deed owner shall be reimbursed the cost of the grave at the time of purchase, minus the Perpetual Care portion of the purchase price (¼ of the total cost).

Perpetual Care will not be returned!

The full purchase price must be paid before a deed will be given or a burial allowed on a lot!

No monument will be allowed in St. Joseph's or St. Patrick's Cemeteries until the entire lot is paid for. Installation of corner stone markers by cemetery personnel is done at the cost of \$50.00 to be paid by the monument supplier to the Cemetery office.

Flower beds or flowers **must be placed next to the monument** (maximum of 12 inches) St. Joseph's and St. Patrick's Cemeteries reserves the right to remove all flowers, wreaths, or other decorations from the lots as soon as they become unsightly

No shrubs shall be planted by lot owners without permission and under the supervision of cemetery staff.

Any tree, shrub, bush, or planting that hinders grass cutting will be removed by cemetery staff.

Funerals must be at the cemeteries **not later than 12:00 P.M.** in order that the workmen will have time to properly close the grave and remove equipment before 3:00 P.M.

No glass containers, vases, or vigil lights of any kind will be allowed in the cemetery.

All foundations will be constructed by cemetery staff only.

Only one monument shall be placed on a lot and shall be set in accordance with the general plan of the cemetery and shall conform to said plan in size and material. **NO** secondary statues that are not part of the original monument design will be allowed. All designs and artwork placed on the face (front) of the monument should reflect Christian-Catholic Faith.

DESIGN APPROVAL IS REQUIRED!

All persons shall be allowed access to the cemetery only during daylight hours

Graves will not be opened after November 15th (weather permitting), or before April 1st (weather permitting), when the frost has left the ground. All bodies received during this time will be placed in the vault for spring burial. These bodies must be removed and interred not later than May 30th.

All bodies left in the vault after May 15th will be removed and interred. If not entitled to burial in a family plot, the body will be interred in a single grave. Those who cause the body to be placed in the vault will pay the expense of such interment. Only such notice shall be given in this case as shall be practical under the circumstances. No burials will be made from winter storage vaults on **SATURDAYS OR SUNDAYS OR HOLIDAYS!**

All lot owners are required to notify this cemetery of any changes of address. All required notices shall be sent to the last reported address and such notice shall be deemed adequate!

ONLY FLUSH MARKERS WILL BE ALLOWED ON THESE LOTS!

Fee for Disinterment of Bodies:

\$1500.00 to excavate down to the vault or box for removal of the body.

Removal of vault or box to be arranged and paid for by the party requesting removal of the body thru a local Funeral Director.

\$750.00 for removal of ashes

*****Please note that strict rules and regulations must be followed when disinterring remains.**
